





Nothing in this MOU shall be constructed to make party a partner, an agent or legal representative of the other for any purpose.




3. This co-operation will facilitate effective affiliation of the intellectual capabilities of their faculties, providing significant inputs to them in developing optimal learning system.




Termination:

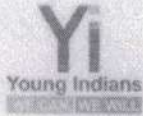

ARTICLE II: Financials
