Minutes of the meeting of IQAC convened on 23rd March 2022.

At the outset, Dr. Richa Thakur welcomed the guests, and introduced the new member of IQAC Shri. Vikas Panchakshari, and thanked him for his co-operation. The meeting started with the address by Dr. Amita Sehgal, Coordinator IQAC, who described the journey to NAAC evaluation process and the result of the assessment, in which the college obtained B++ grade and 2.79 CGPA. She enumerated the details and the points obtained in each criterion. She also discussed about the points suggested by the NAAC peer team towards improvement.

The plan of implementation of some of the suggestions has been prepared and action is being taken accordingly. Dr. Amita Sehgal informed the IQAC members that a Value Added Course has been concluded in the department of Dance. The college had submitted AQAR 2020-21 on 8th of January 2022 and the same has been approved by NAAC on 14th of January 2022.

The college has applied for NIRF ranking. It is a matter of pride that the Department of Biotechnology, Government of India has selected the college for the Star College scheme and it is the only institution from this state to be granted this prestigious status.

External expert Dr. Pradeep Agnihotri congratulated the college on being conferred with B++ grade, and stated that the college should have received a higher grade in comparison to the preparations. Still the criteria 1 and criteria 3 should be given more attention in the next cycle. The recommendations of peer team should be followed diligently. All faculties should publish at

least two research papers every year. Seminars or Webinars should be frequently organized. It is highly commendable that this college has submitted its AQAR according to new pattern.

Emphasizing on the fact that this college could not get a better grade despite its praiseworthy efforts, external expert Shri. Vikas Panchakshari suggested having a direct contact with NAAC, through involvement in its seminar programmes.

Shri Kamal Rungta, member of IQAC suggested that the hostel of the college should be renovated and efforts should be made for organizing crash course in English and for additional teaching posts in the department of English. Social Worker Shri Mohan LalAgrawal reiterated the fact that this college holds a special place in the Durg district, and all necessary resources should be arranged for this college.


NAAC in-charge, Dr D. C. Agrawal enumerated the arduous voyage towards NAAC evaluation during the difficult COVID times and expressed his elation that the college still received an honourable grade. He also pledged to increase the efforts of the college team to achieve an A grade in the next cycle by implementing all recommendations of the NAAC peer team.

Principal Dr. S. C. Tiwari said in his address that all the members of college staff have given their hundred percent during the assessment process. The reason of not getting a higher grade was our inability to showcase our achievements impressively. In future the infrastructure of the college shall be enhanced. A new Computer Laboratory and renewed efforts for research are needed urgently. An IT literacy training programme for office staff shall be organized soon. The DBT Star college funds shall be utilized for laboratory equipments and other resources.

In the end, Dr. Richa Thakur, expressed gratefulness towards the members, on behalf of the IQAC committee, and the meeting was concluded.

CL.1. The MoU

CL.1.1 This MoU made and entered into on 10 March-2022 between Chemistry department of K.R.G College an affiliated autonomous college of Jiwaji University (hereinafter called KRGC which expression shall where the context so admits include its successors and permitted assigns) of the one part,

And

CL.1.2 Department of Chemistry, Govt. Dr. WWP Girls PG College, Durg, an affiliated Hemchand Yadav University, Durg (hereinafter called the WWPGC which expression shall where the context so admits includes its successors and permitted assigns) of the other part.

CL.2. PREAMBLE

CL.2.1 The Chemistry department of KRGC and WWPGC, have realized the need for a close linkage between the two departments/centers in terms of research and academic activities. In compliance to this idea, both have decided to sign a memorandum of understanding (MoU) as per the following terms and conditions.

CL.3. GENERAL


CL.3.1 The faculty of KRGC may participate in the teaching program in the area of Chemistry and research of WWPGC, if desired so, on request and subject to mutual convenience.

CL.3.2 The faculty of the departments will work towards joint research activities thereby mutually using leading research facilities developed/ to be developed at KRGC and WWPGC.

CL.4. Academic and Development Programmers

CL.4.1 For the mutual benefit of the two departments i.e. KRGC and WWPGC, there will be exchange of faculty members of the mentioned department (as mentioned at point 3.1) as per mutual convenience.

CL.4.2 KRGC and WWPGC faculty members will help each other in preparing common research program.



CL.4.3 The students/researchers working at KRGC shall be allowed to use the facilities of WWPGC as per the norms of Jiwaji University, Gwalior if any.

CL.4.4 KRGC and WWPGC will work closely to generate appropriately trained manpower in the related area through skill development programs, organization of formal academic curricula, symposia, short term training courses etc.

CL.4.5 Honorarium and TA/DA (if applicable) will be provided to the faculty to the faculty members as per rules by host organizations.

CL.4.6 The faculty of KRGC and WWPGC may apply for joint collaboration research projects and patents to National and International funding agencies. Data generated through such collaborative research will be published in peer reviewed journals jointly by the faculty of both the institutions.

CL.5. DURATION OF MoU

CL.5.1 This MoU shall be valid for a period of 36 months from the date of signing. The duration may be extended with the consent of both the parties under mutually agreed terms and conditions.


